Measure Requirements

Eligible members who had at least one dispensing event for a statin medication of the appropriate intensity during the measurement year (2024).



Member Requirements

Members with a diagnosis of diabetes or a diagnosis of ASCVD (history of MI with an inpatient admission, CABG, PCI, or a diagnosis of IVD) during the measurement year (2024) and prior year (2023) who were males ages 21–75 with cardiovascular disease and members (male and female) ages 40–75 with cardiovascular disease or diabetes as of December 31 of the measurement year (2024) and did not have the following in the measurement year or the year prior to the measurement year:

- diagnosis of pregnancy
- in vitro fertilization
- dispensed at least one prescription for clomiphene (Clomid®)
- ESRD
- cirrhosis
- myalgia
- myositis
- rhabdomyolysis
